### **HOW TO GET TO VENUES**

#### From Amsterdam Schiphol Airport:

Take the Intercity train just outside the arrivals gates and in the underground train station at the airport, to the train station "The Hague Central Station" or the train station "The Hague Hollands Spoor" (Den Haag Centraal resp. Den Haag Hollands Spoor).

Single fare around € 8,50.

From either of both train stations the Venues are within approximately 2 km walking distance, but taxis are available.

#### From Rotterdam Airport:

The most efficient way of transportation to the Venues is by taxi. Distance is approximately 20 km and will take half an hour (outside rush hours).
